

4-H Area Horse Show Hardship Exemption Information

DEADLINES:

- **March 1, 2025**
 - Exemption request form must be completed (including County Agent signature) and **received** by the State 4-H Horse Program Coordinator (imatwist@ufl.edu or PO Box 110910 Gainesville, FL 32611)
- **March 14, 2025**
 - Decisions on exemption acceptance will be sent out to those who submitted requests
- **June 20, 2025**
 - All documentation for alternative horse shows and educational events must be submitted to the State 4-H Horse Program Coordinator (imatwist@ufl.edu)
 - Please be sure to include 4-Her's name in the email

Acceptable horse shows must meet the following requirements:

- Be completed during the current 4-H year (on or after September 1st, 2024)
- If your county has a requirement to participate in a show to qualify for the Area Show, the same show cannot be used to meet both your county's eligibility for Area and your Area's eligibility for State
- Can be any discipline/type of show (i.e. rodeo, breed show, open show, benefit show, etc.)
- Appropriate documentation includes class placings, high points results, entry confirmation/receipt, etc.

Below is the list of acceptable horse educational events:

- Horse-related Presentation or Demonstration (County level minimum)
- Horse-related Public Speaking (County level minimum)
- Horse Judging (Florida State Fair Contest and/or State Horse Judging Contest)
- Hippology Contest (State level minimum)
- Horse Quiz Bowl (State level minimum)
- Appropriate documentation can be entry confirmation and/or placings/results
